FOREWORD

It is a matter of regret that, due to the decision of the powers that be to give up dairy farming, the Management Committee of the Graylingwell Hospital have been instructed to disperse this herd of Dairy Shorthorns, which in the comparatively short period of twelve years has built up a high reputation as one of the heavy milking herds of the breed.

When founded in 1944 the policy of the Management Committee and its manager, Mr. W. H. Higgott, was to establish a herd with an average of at least 1,000 gallons of milk combined with constitution and the ability to produce a good body of beef. By 1948 this object had been attained with an average herd yield of 10,566 lb. Since that time these high yields have been maintained and increased, as is shown by the following list of yearly averages:

These records have been obtained with the cattle lying out all the year round in exposed conditions and such figures speak for themselves, and it is doubtful if such consistent averages can be equalled by any herd of the breed. The results have been obtained by rigorous culling, and all cows not achieving a yield of 800 gallons with their second calves have been disposed of for beef.

The showing of individual animals has not been part of the herd policy, but many outstanding successes have been won in herd and milk production competitions. For the last eight years the North Challenge Cup for the highest average for the breed in the county of Sussex has been awarded to the herd. In 1952-53 the B.O.C.M. Cup for the highest yield in the county against all breeds was won. In 1954 the £100 first prize in the B.O.C.M. National Milk Yields and first prize in the longevity section came to Graylingwell, while in 1955 the herd was second for both these awards. In 1954 the herd was second in Section B, to the winner of the King's Cup and in 1955 won the Regional Herd Competition for Sussex. Since the herd was started no fewer than seven cows have been awarded certificates for life-time yields of over 100,000 lb., two of these cows being still in the herd, one being the great milking cow Gracie, lot 2, with a life-time yield to date of over 185,000 lb. with eight calves. This wonderful milker should shortly complete her seventh consecutive yield of over 2,000 gallons, and has twice won the Shorthorn Society's Gold Cup. Two daughters of this famous cow are included in the sale.

The bulls used in recent years were **IFORD LORD KIRKLEVINGTON 24th** and **WINTON LIMELIGHT 15th**. The former left many heavy milkers in the herd, and was himself a son of a 100,000-lb. cow. Winton Limelight 15th was by the famous sire Clanville Victorious and out of a 1,100-gallon cow, whose dam and grand-dam both had life-time yields of over 100,000 lb. Winton Limelight 15th's daughters have also proved splendid milkers, several having given over 1,000 gallons with their first calves. The bull at present in service is **BONWYCKS BARBARIC PRINCE 2nd**, lot 113. This bull's dam is a 1,200-gallon daughter of Mr. S. M. Roberts' famous cow Boxgrove Barbara 4th, that four times gave over 2,000 gallons at over 4% butterfat.

The dispersal of a herd with such an outstanding record of performance is an event of the greatest importance, and is one that should not be missed by dairy farmers, and particularly those interested in Grading Register cattle. The herd affords an excellent example of what can be achieved by careful selection and good management. It will be seen that many of the cows and heifers will be either freshly calved or down-calving at the time of sale, while others have been mated for summer and autumn calving. The fine lot of young stock from these heaving milking dams are also well worthy of attention.

TUBERCULIN TEST—The Graylingwell herd is Attested and the last official test was in April, 1956. An official of the Ministry of Agriculture will be in attendance to grant removal permits for stock to be sent direct into other Attested and Supervised herds without isolation or re-test on arrival.

VACCINATION—It has been the practice to vaccinate with S. 19 and all except the young calves have been done. This vaccination is an annual event and the ages of the stock done will vary from about 4 to 12 months.

DELIVERY—Stock will be put on rail at Chichester Station at purchaser's risk, free of charge. Written instructions should be left on the form specially provided for that purpose.
